The Bharatiya Janata Party's (BJP) national general secretary Tarun Chugh on Thursday said the Punjab police was working with hands tied at the back and had been keeping information about terrorism and radicalisation in the state under the carpet.

While condemning the incident of the bomb explosion in Ludhiana, Chugh said anti-national forces were taking advantage of the attention on the state government to give security any priority.

He said drones and bombs are being constantly pushed in Punjab by the Pakistan ISI and it was the duty of the state government to remain extra vigilant against it.

Chugh said some senior Congress leaders like Navjot Singh Sidhu keep raising profile for Pakistan Prime Minister Imran Khan and the Pakistan Army chief Bajwan calling them as their friends without realising that they had become a security threat to the country.
